- 2. Updates:
 - a. Sharps Disposal during COVID Per the Hospital's request, created and distributed information on COVID process for sharps disposal, not accepting at SPH at this time, place for disposal is at the Exchange (still happening two times per month, setup as a drive thru) every 1st and 3rd Tuesday 5-7pm at SPH training Center. Exchange volunteers can also pickup sharps (doing this for Lands End), to arrange pickup email HomerExchange@gmail.com.
 - At Home Medication Disposal National Take Back Day cancelled and HPD unable to accept medications at this time. Shared information re: at home disposal with task force and on Facebook.
 - c. Task Force Updates to Senators Lisa Murkowski & Dan Sullivan Per the request of the Senators, gave an update on task force operations. If we have any identified needs, they want to hear from us about them.
- 3. Social Media Campaign Update: Did not address.
- 4. Work Group Updates:
 - a. Prevention Work Group
 - i. Opioid Partial Fill State policy that was passed, but slow/no enactment occurring (both locally and statewide). Barriers exist because of systems currently in place at pharmacies (barriers include: insurance billing, e-scripts are fully filled, lack of knowledge of policy, etc.). Provider/patient communication at the outset (smaller or partial fill) could be the easiest way to see this be successful. Work Group created a questionnaire for local pharmacies, but pharmacy participation is on hold due to COVID response. Working on this issue at both local and statewide levels. Current data (just released within last month on UpToDate also worth sharing.
 - ii. Voluntary Opioid Advanced Directive Folks can voluntarily opt out of receiving opioid Rx



- iii. Alternative Pain Management New topic as of this month. Something that the group is going to look into.
- iv. Bridge device information Kyla shared with work group, Stephanie will send to entire list serve.

b. Treatment Work Group

- Updates to Treatment during COVID: Group looked at local offerings and worked to i. identify gaps. Most folks have transitioned to telehealth (and are seeing better attendance!). Some small groups are still convening in person (honoring physical distancing). Getting folks into treatment at this time is a challenge. Akeela has been assisting with that and required quarantining. Mat-Su just launched a program to provide supports in order to get into programs across state. AA has still been meeting, regulars are showing up, but online format is less accessible to newcomers. ILoveHomer.org has been established to help fill gaps within both local organizations as well as individuals. Updates: SPH/HMC there is a hiring freeze so nurse care manager for MAT is unable to be filled at this time. Entire HMC office went thru De-Stig training. Q: Any local MAT programs looking at using Bridge devices? A: Do not think it is currently being used in our community at this time. CICADA works with PCHS and it is an option for their clients. Between Medicaid and a grant they are at no cost. NTC is looking into it, not evidence based since it is so new, so harder to get funded and long-term success rate is not known. Q: It is used for alcohol withdrawal? A: Unsure, Stephanie will research. Premera BCBS update - covering telehealth and waiving copay. More info here
